AGREEMENT

1. In consideration of credit extended by Extrude Hone Corporation to the above named applicant the undersigned guarantees to Extrude Hone Corporation the faithful payment, when due, of all accounts of the applicant.
 2. Applicant understands and agrees that in the event any warranty or representation is false or is believed in good faith by Extrude Hone Corporation to be false; any covenant or agreement is violated; or Extrude Hone Corporation in good faith deems itself insecure (because prospect of payment is impaired or the prospect of performance of any covenant or agreement is impaired), Extrude Hone Corporation in addition to any remedies provided by law or this agreement, and to the extent provided by the law, may declare that a default has occurred and terminate this agreement.
 3. Applicant verifies that any and all information now or hereafter supplied to Extrude Hone Corporation is true and correct and further agrees to the terms of sales as indicated. Applicant will promptly notify Extrude Hone Corporation of any changes in chief place of business or mailing address.
 4. The provisions of this agreement are hereby made applicable to and shall insure to the benefit of Extrude Hone Corporation successor's and assigns and blind applicant heirs, legatees, devisees, administrators, executors, and successors.
 5. Extrude Hone Corporation will not be held responsible for any lawsuits brought on by improper or unsafe use of any and all products purchased from Extrude Hone Corporation.
 6. Applicant agrees to pay any collection costs incurred to collect the account balance including court costs, collection fees and attorney fees.
 7. When more than one applicant signs this agreement, all agree that whenever the word "applicant appears in this agreement, it shall be read as "each applicant". That any breach of a covenant or warranty by any applicant for any reason other than full payment or any extension, forbearance, change of rate of interest or acceptance, release or substitution of security or any impairment or suspension of Extrude Hone Corporation remedies or rights against one applicant, shall not affect the liability of any other applicant. All applicants waive the right to require Extrude Hone Corporation to proceed against one applicant before any other or to pursue any other remedy in Extrude Hone Corporation power.
 8. Extrude Hone Corporation's acceptance of partial or delinquent payments or failure of Extrude Hone Corporation to exercise any right or remedy shall not be a waiver of any obligation of applicant or right of Extrude Hone Corporation, nor constitute a modification of this agreement, nor constitute a waiver of any other similar default subsequently occurring.
 9. Extrude Hone Corporation in addition and at its sole discretion, may retain an attorney or collection agency to collect applicant's delinquent and unpaid account and any expenses incurred attempting to collect said account. Said amounts of attorney's fees, expenses and costs shall be added to the unpaid balance of applicant's account and shall be due and owing to Extrude Hone Corporation.
 10. Should applicant default in the payment of its outstanding account or should default pursuant to any of the provisions of paragraph 12, then Extrude Hone Corporation shall be entitled to incur expenses for the costs of collection, which amount shall be added to the unpaid balance of applicant's account and shall be due owing to Extrude Hone Corporation.
 11. Applicant will, if any present endorser, surety or guarantors die, pay all of applicant's then outstanding indebtedness or substitute an endorser, surety or guarantor acceptable to Extrude Hone Corporation.
 12. Applicant will execute any additional agreements, assignments or documents that may be deemed necessary or advisable by Extrude Hone Corporation to effectuate the purpose(s) of this agreement.
 13. Applicant agrees that he/she shall pay the entire invoice price according to the terms and failure to pay shall entitle Extrude Hone Corporation to add a 1.5 percent service charge per month on the unpaid balance. Under no circumstances shall interest exceed lawful rates.
 14. Applicant has authority to enter into agreement and any person signing it on applicant's behalf has been duly authorized to execute this agreement for applicant.
 15. Extrude Hone Corporation has the right to recover its merchandise sold from its company to claim as payment on a returned check for insufficient funds, stop payment, or failure to submit payment on a delinquent account.
 16. Any company who has a check returned to Extrude Hone Corporation for insufficient funds more than two times will be permanently placed on c.o.d. cash only and subject to termination of this agreement.
 17. Any company on open account which is habitually late on payments will be placed on c.o.d. and subject to termination of this agreement.
 18. All checks returned to Extrude Hone Corporation for any reason will be subject to a \$25.00 returned check fee.
 19. All products remain the property of Extrude Hone Corporation until they are paid in full.
 20. The applicant authorizes Extrude Hone Corporation to acquire any business or personal information necessary, by any credit company to process this agreement.
 21. Either party may terminate this agreement with thirty days written notice.
